2. **Janaki Rural Municipality** invites Sealed Bids from the eligible bidders for the construction of works as per table below under sealed bids and National Competitive Bidding procedures. Only eligible bidders should participate in this bidding.
3. Interested Bidders may obtain further information and inspect the Bidding Documents at the office of **Janaki Rural Municipality, Office of the Rural Executive, Khajura Khurd, Banke**.

5. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Janaki Rural Municipality Office's Account No: B 141498321524001 (Dharauti Khata), NIC Asia Bank, Khajura Branch, Banke**.
6. Pre-bid meeting shall be held at **Janaki Rural Municipality Office one week (7 days) before the last submission date**.
7. Sealed bids must be submitted to the office of **Janaki Rural Municipality, Khajura Khurd, Banke** on or before **12:00 Noon on date as per table**. Bids received after this deadline will be rejected.
8. The Bids Shall be opened in the presence of Bidder's Representatives who choose to attend at 1:00 PM on date as per table below at the office of **Janaki Rural Municipality, Khajura Khurd, Banke**. Bids must be valid for the period of days as per table after bid opening and must be accompanied by a bid security, amounting to minimum of as per table below which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing, submission or opening falls on government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of submission.
